

JUDGMENT

This cause came on regularly for trial on May 20, 2002, in Department 210 of the above-entitled court, before the Honorable Thomas J. Mellon, Jr., judge presiding, sitting without a jury, a jury having been waived. Plaintiff, PACITA CO, appeared in pro per and defendant, RICARDO TEJADA, appeared with counsel, Sara B.
